Conditions for changing the contract	 The Ordering Party allows for the possibility of introducing significant changes to the provisions of the concluded agreement with the selected Contractor in relation to the content of the offer based on which the Contractor was selected, in particular in situations specified in the Guidelines on the eligibility of expenditure under the European Regional Development Fund, the European Social Fund and the Cohesion Fund for the years 2021-2027. The Ordering Party provides for the possibility of changing the provisions of the concluded agreement in relation to the content of the offer based on which the Contractor was selected, if such changes resulted from: circumstances of an objective nature that could not be foreseen at the time of conclusion of the agreement; in connection with the occurrence of force majeure, i.e. an unforeseeable event beyond the control of the parties to the agreement, The Parties also allow for the possibility of changes resulting from changes in the data of the Parties disclosed in public registers and changes concerning the designation of representatives of the Parties designated to conduct matters related to the performance of the contract, as well as changes beneficial from the point of view of the performance of the subject of the contract, in particular accelerating the performance, reducing the cost borne by the Ordering Party for the performance of the subject of the contract. In such a situation, the Parties shall introduce appropriate changes to the contract indicating new data resulting from changes in public registers or, guided by respect for mutual interests, the principle of equality of the parties and equivalence of benefits and, above all, the unanimous intention to perform the subject of the contract, shall specify changes beneficial from the point of view of the performance of the subject of the contract. Exclusions The Contractor cannot be an entity/person: 1. related by capital or personal ties to the Ordering Party. Personal or capital ties are understood as mutual ties between the Ordering Party or persons authorized to incur liabilities on behalf of the Ordering Party or persons performing activities on behalf of the Ordering Party related to the preparation and conduct of the Contractor selection procedure and the Contractor, consisting in particular of: a) participating in a company as a partner in a civil partnership or partnership, holding at least 10% of shares or stocks (unless a lower threshold results from legal regulations), performing the function of a member of a supervisory or management body, proxy, attorney, b) being in a marital relationship, a relationship of kinship or affinity in a direct line, a relationship of kinship or affinity in a collateral line up to the second degree, or being related by adoption, care or guardianship or being in cohabitation with the contractor, their legal representative or members of the management or supervisory bodies of contractors applying for the contract award, c) being in such a legal or factual relationship with the contractor that there is a justified doubt as to their impartiality or independence in connection with the contract award procedure. 2. in relation to whom liquidation has been opened or whose bankruptcy has been declared, with the exception of contractors who, after the declaration of bankruptcy, entered into an arrangement approved by a final court decision, if the arrangement does not provide for the satisfaction of creditors through the liquidation of the bankrupt's assets; 3. is in arrears with the payment of taxes, fees or social or health insurance contributions, except for cases where they have obtained a legally provided exemption, deferment, instalment payment of arrears or suspension of the entire execution of the decision of the competent authority; 4. who has submitted false information affecting the outcome of the conducted proceedings; 5. who has not submitted a declaration on the fulfilment of the conditions for participation in the proceedings or documents confirming the fulfilment of these conditions or the submitted documents contain errors. The offer must include the date of preparation and a legible (or with a personal stamp) signature/s of the person/s authorized to represent the Bidder or: electronic signature of the person/s authorized to represent the Bidder. 4.
