2. Subject-matter of the procurement

The subject of the procurement is delivery of new materials for the creation of medical devices, which will be used by the Ordering Party to build prototypes of a medical device.

The materials will be used to build prototypes of medical devices that are under development. Therefore, it is not possible to precisely define the target quantity for the implementation of the task.

The estimated order quantity indicated in the inquiry is the maximum quantity planned for the order. The minimum order quantity will be 70% of the indicated quantity.

Materials can be ordered / delivered successively, along with the progress of work in the project and the resulting demand. The exact terms will be agreed with the selected supplier (s).

If the materials are available in collective packaging or in predetermined dimensions, where the minimum quantity exceeds the planned order, the Ordering Party will purchase collective packaging/determined dimension that is the closest to the ordering quantity indicated in the inquiry

Regardless of the above, the Ordering Party allows the possibility of submitting supplementary orders.

It is possible to submit partial offers.

6. Deadline and method for the submission of bids:

Until: **10/22/2021** (October 22nd, 2021) until 23:59 (The date of receipt of the offer is counted in the case of submitting the offer in person and by e-mail, or the date of sending the offer in the case of its submission by post / courier, the tenderer is obliged to inform the Ordering Party about sending it by e-mail by the time of deadline for the submission).

The offer should be submitted on the offer form constituting Appendix 1 to this inquiry. The offer form should be accompanied by a signed declaration constituting Appendix 2 to this inquiry.

By submitting the offer, the Bidder guarantees the delivery of the subject of the contract in accordance with the description indicated in point 2.

7. Realization date of the agreement

The term of delivery of a given item of the subject of the order is up to 14 weeks from the date of signing the contract / placing the order.

Deadline for placing an order: no sooner than the day after the end of the inquiry period, within 90 days from that date.

8. Terms of significant changes to the contract

The Ordering Party provides for the possibility of changing the provisions of the concluded contract, in particular in the event of circumstances that could not be foreseen at the time of concluding the contract, or if they result from the introduction of changes in generally applicable provisions of law in the scope affecting the implementation of the subject of the contract.

In particular, the changes may concern:

- · order prices,
- the method of remuneration for the performance of the contract,
- order completion date,
- contract performance conditions











The Ordering Party also reserves the right to change the terms of the contract in relation to the content of the submitted offers, in accordance with the provisions set out in the *Guidelines on the eligibility of expenditure under the European Regional Development Fund, the European Social Fund and the Cohesion Fund for 2014-2020*, chapter 6.5.2, point 20.

9. Information on supplementary orders

The Ordering Party provides for the possibility of awarding a supplementary contract in the amount of up to 50% of the value of the basic contract, as specified in the contract concluded with the selected contractor, within 3 years from the date of awarding the basic contract.

10. Information on the possibility of submitting partial and variant offers

The Ordering Party allows partial offers to be submitted.

The Ordering Party does not allow variants to be submitted.

11. Information on the prohibition of personal or capital ties

The Procurement may not be awarded to a related entity with the Ordering Party in person or in capital.

Capital or personal ties are understood as interrelationships between the Ordering Party or persons authorized to incur obligations on behalf of the Ordering Party, or persons performing activities on behalf of the Ordering Party related to the preparation and conduct of the contractor selection procedure, and the contractor, in particular consisting in:

- participation in the company as a partner in a civil partnership or a partnership,
- possession of at least 10% of capital or shares,
- holding the position of a member of the supervisory or management board, a proxy, an attorney,
- being bound by marriage, direct kinship or relation, secondary kinship or relation up to second degree, or a relation of adoption, custody or guardianship.

12. Information on possible questions regarding the inquiry

13. Information on possible changes

The content of the inquiry or its attachments may be changed before the deadline for submitting tenders in the inquiry, incl. as a result of providing explanations to questions sent by tenderers.

In this case, the Ordering Party will include information about the change in the published inquiry. This information will include at least: the date of publishing the changed request for quotation as well as a description of the changes made. The Ordering Party will extend the deadline for submitting tenders by the time necessary to introduce changes to tenders, if it is necessary due to the scope of the changes.

14. Information on the possibility of

The Ordering Party reserves the right to cancel or cancel the inquiry without giving any reason. The possibility of canceling a request for quotation may

canceling and invalidating the inquiry

arise in particular when the price of the best offer exceeds the planned and available funds for the award of the contract.

Information on the possibility of correcting submitted offers

In the course of evaluating the submitted Tenders, the Ordering Party may request the Tenderers to supplement the documents once (if it does not infringe the competitiveness) and / or to correct obvious mistakes and errors.

The deadline for submitting supplements will be indicated in the message sent to the Offerer (at least 2 working days from receiving the request). The Tenderer may authorize the Ordering Party to correct the documents on his behalf.

Not submitting explanations and / or supplementing documents in the time and form specified by the Ordering Party will be the basis for rejection of the Offer.
